Format of the meeting

Since the CPS has re-integrated with the Congress, the annual meeting will take place from May 31 to June 2, 2023 at York University (Keele Campus) during the [Federation of Humanities and Social Sciences Congress](#). The 2023 annual meeting will be a hybrid conference; you can participate in regular/special sessions and the AGM in-person and/or remotely. Details on remote access to the meeting will be available soon.

Social events such as the CPS reception, CPS graduate student professional development event, CPS banquet, and the Congress President's Reception for the CPS, will be in-person only.

Registration for Congress 2023 is open

Attendees of the 2023 CPS annual meeting are required to register for both the CPS annual meeting and Congress on the [Federation's registration website](#). There is an early-bird discount for those who register for Congress before March 31, 2023. CPS members are encouraged to [renew their CPS membership](#) to take advantage of the discounted CPS registration fee (\$75 for regular CPS members; \$35 for emeritus/student members). 2022 CPS memberships expire on January 31, 2023.

Funding/award opportunities

1) Student presenters will have opportunities to nominate their papers for the Best Student Paper Award and apply for the Congress Graduate Merit Award. The CPS student paper competition committee will reach out to students whose abstracts are accepted to regular or poster sessions on these awards.

2) Attendees to the CPS annual meetings are eligible to apply for the Congress Child and Dependent Care Subsidy. The subsidy program is designed to help offset the additional cost of child/dependent care for presenting participants at Congress 2023. This program provides support of a maximum of \$200 reimbursement for expenses to enable Congress presenters with dependent care responsibilities to participate in Congress activities. The CPS EDI committee will announce the application procedure soon.

Census 2021



Once every five years, the [Census of Population](#) provides a detailed and comprehensive statistical portrait of Canada. The 2021 Census data have arrived. Starting in February 2022, there will be seven major releases over the

course of the year. Each release will provide data, analytical, and reference products. Read [The Daily](#) for announcements about future Census releases. The December 2022 issue of *Survey Methodology* is now available. The issue contains 12 papers including an invited paper on the Bayesian approach to survey inference and a special discussion paper (with commentary) on statistical inference with non-probability survey samples. There are also papers on deep learning models for missing data imputation, multilevel time series modelling, linear estimation in two-phase sampling, and Bayesian spatial models.
