

Census 2021



Once every five years, the Census of Population provides a detailed and comprehensive statistical portrait of Canada. The 2021 Census data have arrived. Starting in February 2022, there will be seven major releases over the


Data Products

Data on the Express Entry of skilled workers to Canada has been integrated into the Longitudinal Immigration Database (IMDB). The data include elements of the preadmission competencies and qualifications of Express entry applicants.

The Social Policy Simulation Database and Model (SPSD/M) version 30.0 was released on June 12, 2023. This version of the SPSD/M can be used to examine the effects of changes in federal and provincial tax and benefit programs on families and governments from 1997 to 2027. Version 30 of the SPSD/M incorporates changes to income taxes and government transfers announced before December 31, 2022.

The Income Research Paper Series has released a review of Canadian homelessness data. The review includes an environmental scan of Statistics Canada data sources and identifies gaps in the current data.

The Proximity Measures Database, 2021 is now available online. The databases includes 10 measures of proximity to amenities and a composite indicator at the

dissemination block level. A separate database for rural and small towns in Canada – ProximityRST – has also been released.

Historical tables on mother tongue (1951-2021), language most often spoken at home (1971-2021), and first official language spoken (1971-2021) are now available.

Family and individual income data for 2021 are now available from the T1 Family File (T1FF) for Canada, the provinces, the territories, and various sub-provincial and sub-territorial areas.

Briefs

On June 16, 2023, Canada's population reached 40 million people. The population increased by 292,000 people in the first quarter, the highest rate of growth ever observed. The majority (98%) of this growth came from immigration. Check out the Eh Sayers podcast entitled Will the 40 millionth Canadian please stand up?, which features an interview with Laurent Martel, director of the Centre for Demography.

The growth of housing stock outpaced population growth in Toronto and Vancouver from 2019 to 2021, according to data from the Canadian Housing Statistics Program (CHSP). New condominiums were a key contributor to the growth of housing stock in Vancouver. The latest release of CHSP data on residential properties was expanded to include Prince Eward Island, Saskatchewan, and Alberta. The CHSP now includes covers all provinces and territories in Canada, except Quebec.

In 2022, Canadian employees in the top decile of the wage distribution had an hourly wage 340% higher than those in the bottom decile, according to an article on the distribution of wages in the latest issue of *Quality of Employment in Canada*. The issue also features analytical papers on involuntary part-time employment, average weekly working hours and the distribution of working hours, night work and evening work, flexible work schedules, commuting time, parental leave, and participation in training.

Analytical Products

The June 2023 issue of *Survey Methodology* has been released. The issue features articles on combining data from surveys and related sources and survey data integration for regression analysis in addition to five other regular articles and four special articles in memory of Chris Skinner, one of the "top social and survey statisticians in the world."


