Statistics Canada Updates

The Statistics Act

The Act to amend the Statistics Act received Royal Assent on December 12, 2017. The Act entrenches Statistics Canada's independence into law, and ensures greater transparency about statistical matters. The Honourable Navdeep Bains, Minister of Innovation, Science, and Economic Development, says "One important criterion for high-quality data is impartiality. The quality of statistical information is maximized when decisions on statistical matters and operations are not subject to control by the government." The act also removes the threat of imprisonment for refusing to participate in mandatory surveys, makes provisions for transparent decisions on statistical matters, such as the requirement to publish in advance the survey questions that will be requested from Canadians on a mandatory basis, and creates the Canadian Statistics Advisory Council to advise the Chief Statistician and the Minister on the overall quality of the national statistical system.

2016 Census of Population

Statistics Canada has also released an interactive <u>Census Program Data Viewer</u> dashboard allowing for the visualization and interpretation of key demographic indicators such as age, sex,

language, income, education, employment, and many others. The Viewer makes it easy to search for places in Canada, visualize them on a map, display their geographic and sociodemographic data, and compare with other regions. This <u>tutorial</u> shows users how to quickly begin performing in-depth analyses of Census data using the Viewer. Statistics Canada publishes several other types of <u>data visualizations</u>, infographics, and videos suitable for interactive classroom use.

Methods: Linking the 2006 Census of Population to the Canadian Mortality Database: Descriptive and Validation Study

The Canadian Mortality Database (CMDB) is an administrative database that collects information on cause of death from all provincial and territorial vital statistics registries in Canada. The CMDB lacks subpopulation identifiers to examine mortality rates and disparities among groups such as First Nations, Métis, Inuit and members of visible minority groups. Linkage between the CMDB and the Census of Population is an approach to circumvent this limitation. This report describes a linkage between the CMDB (2006 to 2011) and the 2006 Census of Population, which was carried out using hierarchical deterministic exact matching, with a focus on methodology and validation.
